3. OBJECTS OF THE TRUST :

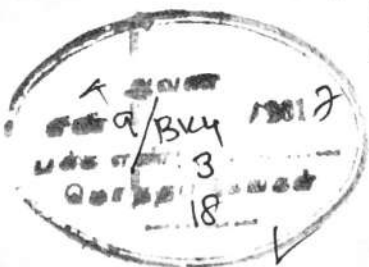

- To provide children Kindergarten Education by conducting classes and to promote Art, Literature and Education.
- To start Schools Colleges and Professional Institutions for the poor, destitute & down trodden.
- Educational service for the upliftment of the Society without the discrimination of caste, religion and language.
- Arranging to study and promote the International Art, Sports & Games, Yoga, Meditation and Exercise, extending the Advanced Art and Literature Creations before the people.
- Establishing the Environmental Institutes, Laboratories and Documentation Centers, Industrial Training Centers for the self-employment Schemes.



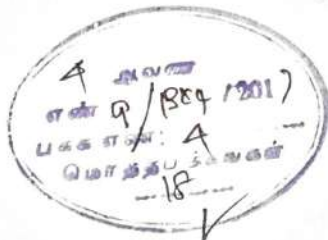

- h. Children's Home Orphanages, Mercy & Aged Homes. To render all possible helps for the Street Children and Abused Children.
- i. To create awareness among the people for the protection of the environment and provide educational facilities for displaced persons and to assist them in obtaining such facilities in Educational Institutions.
- j. To propagate Indian languages like Hindi, Sanskrit, Tamil etc., and foreign languages like English French, Japanese etc., and to raise fund from Government, Inland and foreign countries to teach the above languages.

3.2 EDUCATIONAL, MEDICAL, ENGINEERING, ARTS, SCIENCE COMMERCE, AND MEDICAL RESEARCH, RESEARCH FOUNDATIONS, AND MUSIC RESEARCH, SCIENTIFIC RESEARCH, RURAL DEVELOPMENT ETC.

- a. To establish, maintain, run, develop, sponsor schools, Technical Training Schools, Teacher's Training Schools, Colleges, Research Institutions, Universities, Institutions for Scientific Research, Statistical Research, Polytechnics, Professional Institutions, Industrial Schools, Medical and Medical Research Foundations.
- b. To construct, buy or acquire lands and buildings for the above institutions, institutions for carrying on a programme of conservation of natural resources or rural development or for afforestation. To provide hostels for students studying in the above institutions.
- c. To purchase, acquire and otherwise make available such copy right in distribution relation to any books, manuscripts, research papers, journals and periodicals, with a view to develop print, publish and distribute the same by the trust itself or in collaboration or association with others for disseminating knowledge in any subjects, national cultural and traditions, in furtherance or education's intended to students of schools, research school colleges and research fellowship to universities and research institutions.
- d. To organize and conduct lectures. Seminars, symposiums and workshops for students and other beneficiaries.
- e. To conduct programmes to create awareness on AIDS & personal hygiene
- f. The Trust will help the students for their education in Graduate and Postgraduate levels, higher studies in foreign country. The Trust will help the Graduates, Post Graduates and technically qualified persons in getting suitable jobs in Private and Government organizations. Further the trust will help the self-employed persons in getting loans and other necessary assistance.
- g. To give donation to educational institutions of any kind referred to clause above.
- h. To publish or assist in the publication of books periodicals and journals in connection with the above subjects.

- i. To establish, maintain, run, develop, sponsor Music & Dance schools, Music & Dance Teacher Training Music correspondence course, yoga, Meditation, etc.,

3.3 MEDICAL RELIEF, INCLUDES ESTABLISHMENT OF EYE RESEARCH INSTITUTION & FOUNDATIONS, EYE HOSPITALS, DENTAL HOSPITALS, ENGINEERING, MEDICAL INSTITUTIONS ETC.,

- a. To provide, endow and establish charitable Hospitals, Dispensaries, Chemical Laboratories and X-ray institutions, and to maintain and manage such establishments in all branches of science.
- b. To arrange employ, surgical, medical and pharmaceutical officers, nurse, doctors and attendants and provide and supply to other charitable medical institutions, transport facilities provides van to take care of patients from home to hospital or vice versa.
- c. To educate and maintain medical students and nurses and other paramedical personnel by way of classes, seminars, lectures, symposiums and workshops, etc., in the prevention treatment to the diseases. To provide yoga meditation activities.
- d. To award grants, scholarships, fellowships and similar financial assistance or encouragement for advancement of research in medical science and engineering.
- e. The advance of research in medicine in allopathic, homeopathic. Yogic, ayurvedic, unani or any other system or systems with particular reference to development of new drugs or medicines and obtain donations thereof and to associate with foreign research institutions, receive foreign grants by way of donations for the purpose of hospitals, etc., in furtherance of cure of incurable and chronic diseases.
- f. To establish Blood Bank, Eye Bank and to maintain hospitals, science technology and medical research foundations or schools and to register the name of Eye, Blood donors or to purchase human Eyes or otherwise use and transplant the Eyes, Blood to the needy persons.
- g. To provide medical and legal aid and other facilities to displaced and affected persons. And to establish blood bank and run charitable hospitals, conduct health camps, for the benefit of poor and deserving community.
- h. To offer services to humanity in collaboration with Red Cross. NGOS, WHO and other National and International Societies and to do all such other lawful things as are incidental or conducive to the attainment of any of the above objects.
- i. To arrange for Medical Educational programmes to discuss developments in Emergency medical care and to arrange for Meetings and get together or promote friendship among the members.

- j. To organise Training Courses for health and family welfare personal in the form of public demonstration. Skit, drama, Music, quiz competition to undertake research activities on health family welfare and immunisation etc. To promote the Association.
- k. To educate poor people on health, nutrition, sanitation and personal hygiene, to develop methods and techniques for the deliver of health care services.
- l. Construction of dwelling units for the economically weaker sections and the construction of low-cost latrines for rural sanitation.
- m. To provide prevention to the public for contagious diseases and undertake all activities to relief contagious diseased, and to arrange medical camps, other necessary facilities.
- n. To arrange Literacy classes for Drivers and Adults on traffic rules and regulations. To make use of audio-visual aids to support the literacy activities.
- o. To conduct research in social, economic, scientific fields for human development and social welfare.
- p. To undertake activities for the prevention to the affected Leprosy persons and we provide relief to them by way of regular medicine, to arrange accommodation, Food, Cloths, Shelter, etc.,
- q. To provide relief and aid to the public affected by natural calamities like earth quakes, cyclones, floods, famines, Tsunami, Fire, etc., and also to provide for education and maintenance of poor and needy windows irrespective of caste.
- r. To carry out or attend to such objects or purposes which are of charitable nature without any discrimination of caste, creed or religion or sex.

3.4 RELIEF TO THE DOWN-TRODDEN, WEAKER SECTIONS OF THE SOCIETY, HANDICAPPED AND EX-SERVICEMEN.

- a. To take active interest in the civil, social and normal welfare of the youth community without any restrictions as to the caste or community or creed and to provide them the bare necessary.
- b. To arrange for reading, provide free cloths, environmental hygiene water booths and all welfare measures to uplift the dalit, downtrodden, refugees, tribes, transgenders and weaker sections of the society and the trust has intention to work for the dalits, downtrodden poor women & children.
- c. To rehabilitate dalits, downtrodden, weaker sections of the society, handicapped, ex-servicemen and women by training, education, providing suitable jobs and arranging for self employment schemes.

- d. To plan, promote, undertake and assist programmes for agricultural development, Animal Husbandry market processing, Cow Butchering Abandon, Relief to all animals, supply and storage of agricultural products, small scale industry, cottage industry, Agro industry, providing, arranging technical know-how, managerial assistance, financial assistance, conduct of survey research study and other activities which will enable men and women for their better living, help them to improve their standard of living.
- e. To establish schools, colleges, technical and other Institutions, professional colleges, for imparting general, academic technical or professional education to students at large scale as under laws and rules in force.
- f. To promote employment to women, rehabilitation centers partnership among women, educational training and financial assistance.
- g. To rehabilitate displaced persons and to provide or assist them in finding necessary modes of sustenance's.
- h. To investigate the Cause of displacement and disturbance and to compile information on such causes and to do all what is necessary to prevent the recurrence of such causes of Displacement.
- i. The Trust will give stipend to the Children of socially affected women. It also draw some useful welfare schemes for the divorced women, socially backward women, women affected by some chronic incurable diseases, women affected by AIDS.
- j. To purchase lands, agricultural lands, or acquire lands buildings or to take on lease of lands, buildings, etc., to run the above activities.
- k. To identify the Socio-economic conditions and needs of the vulnerable sections, labourers in organized and unorganized sectors, consumers, former women, children, orphans, aged sick, physically, visually and mentally challenged and all uncared section of Indian Society.

3.5 TO PROMOTE THE POOR WOMEN AND CHILDREN

- a. To conduct and promote such charitable activities for the general welfare of the poor women and children in the rural, Urban, Slum areas, and maintain hospitals and charitable dispensaries for rural women and children.
- b. To form women & men Self Help groups and undertake activities for their development. To promote and encourage primary & Higher Education, Training in Handicrafts, Cottage, and Industries for women and children.
- c. To Provide sanitary facilities for women and children and promote preventive measures affecting the health of women and children in the rural & urban areas.



- d. To train women & men for carrying out any of the aforesaid activities to work for eradication of illiteracy among the rural, urban & Slum people, especially among poor and downtrodden people.
- e. To render help through grants and contributions to any existing institution doing similar work for women and children, to promote, art, culture handicraft and traditional activities.
- f. To promote training needs and entrepreneurial skills for women and men entrepreneurs. Important of training is mainly aimed at providing training needs to rural women.
- g. The trust employ women for manufacture of simple chemicals, food and associate products are marketed keeping no loss and no profit motive.
- h. To organise programmes such as, dry land development, poultry development, dairy development, sericulture development, agro support services, general agricultural extension activities and training programmes.
- i. To arrange for preparing and organizing programmes for the production and development of khadi and village Industries, SSI, including training of personnel, manufacture and supply of equipment, supply of raw materials marketing research and study of economic problems of different village Industries.
- j. To help self-employed women & men expand their business through arranging loans from nationalised banks and to improve their professional and social status by giving them training and establishing day care centres for their children to promote women empowerment.
- k. To work for the welfare of Adolescent, women & Children and also creating awareness generation by conducting Camps.

3.6 OBJECTS OF THE SOCIAL WELFARE

- a. **Physically Challenged, and Mentally Retarded :-** To Provide Shelter, Food, Cloths, Medical Assistance and Education.
- b. **Unwed Mothers :-** To Provide Shelter, Food, Cloths, Medical Assistance to both mother and baby subject to case to case basis.
- c. **orphans :-** To Provide Shelter, Food Cloths, Free education to orphans without parents helpless boys and girls of depressed and minorities and also provide suitable placement to their capacity.
- d. **Free Legal Aids for Eunuch :-** To Make awareness relating to the legal side for the society.
- e. **Free Marriage :-** for the benefit of general public especially the Orphans, destitute, poors.

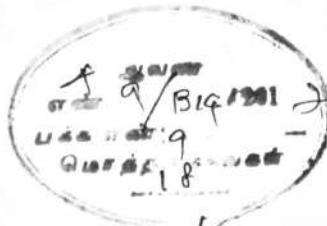

- f. **Adolescent Counseling :-** To conduct programmes for counseling to the Adolescents.
- g. **AIDS and SARC Awareness :-** Creating Awareness among school children, College youth and the general public particularly people living in slums. To print, publish and sell, distribute or otherwise journals, periodicals, books, hand bills, folders, pictures, etc., To construct and maintain community halls, Indian Culture centers etc., for the benefit of general public especially the AIDS victim and the AIDS Orphans. To Co-operate and co-ordinate with other social organization. To conduct programmes and awareness on SARC personal hygiene and also organise free medical camps to give treatment to them.
- h. **Human Rights Awareness :-** To create human rights awareness to the society.
- i. **Child Labour :-** To Conduct programmes to abolish child labour and also provide free education.
- j. **Juvenile Delinquents :-** To render free service helping juvenile in legal aspects.
- k. **Home for aged :-** To provide shelter, food, cloths and medical assistance for the aged people.
- l. Creating awareness among the people for the protection of the environment natural resources afforestation, ground-water replenishments.
- m. The trust will arranged for Research centres i.e., Scientific Research, Statistical Research, Research in Social Science, the National Fund for Rural Development and Contribution to the National Urban Poverty Eradication Fund and others.

3.7 TO PROMOTE AND CARRY OUT THE OBJECTIVES :-

- a. The trust is empowered to apply for and receive grants and contributions both from individuals internal and External Agencies Institutions, State and Central Government.
- b. The trust is empowered to purchase, lease or rent property as and when required to promote and execute the objects.
- c. The trust is empowered to raise loans and such funds from financial institutions and government.
- d. The trust is empowered to take on lease, License, hire or otherwise required to hold, manage administer, deal with movable and immovable property that Board deems necessary.
- e. To appoint persons representatives, agents on their works on such conditions as may be thought necessary by the trust.

- f. The trust funds acquired or earned shall be solely utilized towards fulfilling of the objects and no portion of it shall be utilized for payments to trustees by way of profit interest or dividends or otherwise. The programmes and benefits shall be open to all those who need as the case may be.

3.8 OBJECTS OF THE GENERAL PUBLIC UTILITY :-

- a. To carry out the objects of general public utility, not involving the carrying on of any activity for profit motive such as to establish, run, maintain and develop, public halls, cyclone relief Centers, communal riot relief centers, homes for the aged, destitute men, women and children, on no loss and no profit basis.

b. FOOD & NUTRITION :

- (i) To give employment to handicapped persons, ex-servicemen for the purpose of meeting the objects.
- (ii) To purchase or acquire by donation or reserve agricultural lands for the purpose of meeting the objects.
- (iii) To adopt backward village and to implement welfare schemes for the development of such backward village.
- (iv) To receive and assist for food, clothes and shelter for displaced persons.

- c. To accept foreign contributions on behalf of the trust and utilize such contributions for the purpose of carrying on medical relief to the persons.

- d. To import machinery and receive by way of donation from foreign countries equipments for the purpose of research, especially in the field of medical, scientific and research foundations.

- e. To get necessary exemptions, licence, registration from the government in order to implement the aforesaid purpose early.

- f. To establish Financial Institutions, Social Service Societies and Credit Societies for the support of and maintenance of Institutions connected with such displaced persons.

- g. To do all other lawful things as are incidents to any of the above objects and that the same shall be carried only on no loss or and no profit basis.

4. The activities of the trust shall be confined within India and Trust shall have no power to spend money on any of the objects outside the Indian Territory.

5. BENEFICIARIES :

The Beneficiaries of the Trust shall be the poor, both men and women; children, handicapped and any individual deserving the aid succor and upliftment without any distinction of caste, colour, creed, sex or religion.

7. POWER OF THE MANAGING TRUSTEE :

Managing Trustee of the Trust shall be Executive Head of the Trust. He is empowered to decide in all matters pertaining to the administration of the Trust. He shall preside over all meetings, conduct the meetings in a democratic manner.

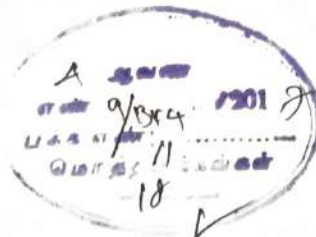
8. POWER OF THE FOUNDER :

The founder shall hold office at her/his pleasure and on the vacation of office, the founder herein on his/her own volition or by death or otherwise the trust can be operated as per the written willingness given by the founder.

9. POWER OF THE TRUSTEES :

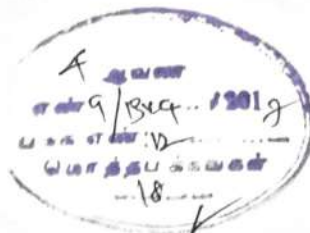
- a. To manage the Trust Fund and collect and recover the interest, dividends and other income there of and to pay and discharge out of the income of the trust fund all expenses and charges for collecting and recovering the income of the trust fund and all other costs. Charges and expenses and out going of and incidental to the trust created by theirs presents and the administration thereof.
- b. To apply the trust money to effectuate on objects or some of the objects of the trust in preference to other object(s). To discontinue the applications of trust funds to the objects and divert the funds to objects of the trust.

- c. To receive donations either by cash or kind of legacy or any other means from foreign countries or in India by way of corpus for on revenue account.
- d. In case it is decided to render financial or other aid to any persons or institutions within the scope of the objects, to decide the terms and conditions which shall be complied with by such persons or institutions.
- e. To determine if necessary, the terms and conditions on which any donation, subscriptions, scholarships or prizes or medals are to be given by the Trust.
- f. To expand the funds of the Trust in such manner ad they consider must beneficial for the objects and purposed of the Trust.
- g. To acquire agricultural lands, build upon, pull down, rebuild, add to, alter repair, cultivate or improve, sell or dispose of any land, building or premises for the use of the Trust and to acquire other movables in tangible benefits of immovable properties.
- h. To take any property on lease or hire.
- i. To let on hire or lease and transfer any movable of immovable properties not immediately required by the Trust.
- j. To acquire any property in exchange for some other property or partly in such exchange and partly for other consideration(s).
- k. To enter into any contract on behalf of the Trust.
- l. To borrow money upon the security of any of the property of the Trust on the terms and conditions that the trustees shall not borrow funds exceeding 75% of the market value of the assets of the Trust.
- m. To make and from time to time repeal add or alter regulations.
 - i) As to the Management of the Trust and affairs thereof.
 - ii) As to the duties and remuneration of Trustees.
 - iii) As to conduct any of the matters of things will be under the control of the trustees provided the same shall not be in consistent with the provisions contained in these presents.
- n. To settle out court compromise or compound all suit actions and other proceedings.
- o. To appoint, and remove managers, Secretary, Clerks and other staff and workers required for the working for general management of the affairs of the Trust.

10. BANKING ACCOUNTS :

The Trust Board shall open on or more Bank accounts in the name of the Trust. All income of subscriptions and pecuniary donations for the general purpose of the Trust and the income from investments and all other money received from time to time forming part of the general revenue of the Trust shall be paid into one or more Banks.

The Trust Accounts should be maintained in the name of the Trust. The Bank Account will be opened by The Managing Trustee And Any one of the Persons Officially Named Secretary of Treasurer Jointly shall withdraw money.

11. ACCOUNTS & AUDIT:

The Accounting year of the Trust shall be from 1st April of 31st March every succeeding English Calendar year. The Founder and Trustees shall be responsible for maintaining proper books of Accounts with respect to.

- (i) All receipts and Payments.
- (ii) Balance Sheet
- (iii) All income and expenditure
- (iv) Books of accounts and financial registers
- (v) Receipt books, bills and vouchers.

A Chartered Accountant of a firm or Chartered Accountants shall audit the account of every year.

The Trust should have the necessary expertise and should maintain separate accounts in respect of the eligible project or schemes under the Income Tax Act 1961 Section 35 Ac.

12. VALUATION :

The founder and Trustees herein may maintain the list of properties acquired, administered and maintained by the Trust and the same shall always invest with the Trust.

13. ADVISORY BOARD :

The Founder and Trustees herein may maintain advisors for better administration of any particular objects engaging their services. The Trustees shall have liberty to fix remuneration for the services rendered by the Advisors.

14. THE TRUST FUNDS :

- a) Donations received.
- b) Donation receive from any individual, public charitable institutions.
- c) Donation / assistance received from Government.
- d) Donation / Assistance received from public
- e) Gifts received for public and institutions.
- f) Voluntary contributions made with specific direction to form part of the corpus of the trust.

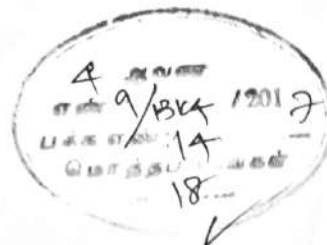

- g) Properties including deposits.
- h) The Income derived from such property/deposits.
- i) Foreign contributions/donation/gifts in the form of articles, currency whether India or foreign security, subject to the provisions of Foreign Contributions (Regulations) Act, 1956 and the Rules framed thereunder.

15. GENERAL FUNCTION :

1. This Trust is revocable . If the Trust hereby constituted fail for any reason in the opinion of the Founder Trust both movable and immovable shall be hand over to any public charitable trust as decided by the majority of the trustees, which has similar objects.
2. In the event of closure of winding up dissolution of the trust all its assets and liabilities, if any shall transferred to another Trust which has similar objects and enjoying Exemption which as registered under section 12A(a), 11 and 80G of the Income Tax Act, 1961.
3. The Total Income of the Trust before giving exemptions exceeds Rs.50,000/- audit report in form-10B shall be filed.
4. The Exemption shall be forfeited on contravention of section 13 of income tax Act, 1951.
5. The income of the Trust shall be applied for the purpose for which it is registered as per section 11(1) or 11(2) accumulated as per section.
6. The income and funds of the Trust shall be solely utilized towards the objects of the Trust and the income shall be utilized for Research Centre. With prior approval of the Director of income Tax (Exemptions) Under Section 80GGA Income Tax Act, 1961.
7. The Trust shall invest the investments as per Section 13(1)(d) read with Sec. 11(5) of the Income Tax. Act, 1961.
8. The Project Scheme of any amendment to the instrument would be carried only with the approval of Income Tax Act, 1961 Section 35AC (Exemption).
9. The Income and funds of the Trust shall be solely utilized towards the objects of the Trust in Section 13(1)(c) of the Income Tax Act, 1961.
10. Any amendment to the instrument would be carried only with the approval of Director of Income Tax (Exemption).
11. Acquisition / alienation of immovable property shall be done with prior approval of the Director of Income Tax (Exemptions).
12. To sell, alienate, lease, mortgage, charge pledge, hypothecate, transfer of otherwise deal with all properties, funds and assets and any amendments to the Trust Deed/Memorandum of Association /Bye-laws will be carried out only with prior approval of Director of Income Tax Exemptions.

- 13. The Benefits of the objects would be available to the general public irrespective of caste, creed, religion or sex.
- 14. The Trust shall apply for exemption under Section 80-G in the prescribed form during the foregoing period.
- 15. The activities and functions of the Trust shall be utilized only towards charitable purpose and not for any profit motive.
- 16. Not more than 5% of the income of the trust/institution would be applied for any religious purposes or given to religious institutions. (any violation found will lead to denial of exemption under Sec. 80G considering the Trust as public Religious in Nature).
- 17. At present the trust have no immovable property. No activities of the Trust will be carried out anywhere outside India, without prior permission from the appropriate/concerned authority of Director of Income Tax.
